## **Demolition has started**

Over the coming weeks, the construction team will continue to demolish the buildings within the footprint of the \$479 million redevelopment of Ryde Hospital.

Before demolition of each building, the team needs to make sure that it is safe to begin work. Ensuring the health and safety of our staff, patients, visitors and construction workers is always our first priority.

Services will be disconnected from buildings earmarked for demolition and any hazardous materials will be safely removed by licensed specialists in accordance with relevant legislation and guidelines. Learn more about the safe removal of asbestos containing material <u>here.</u>

Once the buildings are cleared for demolition, heavy machinery such as excavators will be brought onsite to remove the remaining structure. While this work may be noisy at times, the redevelopment team will continue to work closely with staff, patients and the community to minimise the impact on hospital services.

## **Protecting biodiversity (flora and fauna)**

Ryde has a rich biodiversity with a variety of native plants and animals that form thriving ecosystems. The Ryde Hospital Redevelopment team is committed to protecting the local flora and fauna during the redevelopment.

For all hospital projects, the local biodiversity and existing environment are assessed to determine relevant protection measures. A team of specialists has identified flora and fauna surrounding Ryde hospital and is using this information to carefully plan and implement safeguards around habitats and monitor for the presence of wildlife. If wildlife is found before or during the work, experienced wildlife handlers will be present to safely remove and relocate them.
